Use of the Community Plan

We recognize that many agencies serve families and in society today can be complex. The BVCS Early Childhood Iowa (BVCS ECI) 3-County Board, Decatorganization / Community Partnership for Protecting Children (Dect/CPPC) Boards, along with local Community Coalitions in Buena Vista, Crawford and Sac Counties entities have assembled a Community Plan centered on families and young children. Research from various websites and surveys assisted in the compilation of the materials. The Community Plan is organized in five sections designed to provide a quick guide for your use.

Section 1 emphasis is on identifying the area served, community partners, purpose and geographical/demographics for the threecounty area centered around the zero to eighteen population in Buena Vista, Crawford, and Sac Counties.

The profile assists the BVCS Early Childhood Iowa Area, Decat/CPPC Communities, Child Abuse Prevention Councils and/or readers to understand and make decisions in relationship to the three counties. Utilize the geographical/demographics data to study, capture, and analyze subsets within a given population.

Section 2 examines the community needs assessment completed for the three counties, development of our strategic plan, priorities and community wide indicators used to track programs. Use this information when you are developing or making the case for expanding a current program and/or partnering with BVCS ECI, Decat/CPPC, or Child Abuse Prevention Councils.



Section 5 provides an acknowledgement to those who participated and a summary of the plan. Identifies the resources used throughout the plan.


Geographical /Demographic Profile Composition

Located in West-North-Central Iowa, the BVCS Early Childhood Iowa encompasses the counties of Buena Vista, Sac and Crawford. Decat/CPPC services are provided in Buena Vista County and Crawford, Sac Counties. Child Abuse Prevention Councils that are located in each of the three counties.



Buena Vista and Crawford Counties have a high diversity in race. In reviewing data from the Iowa Department of Education, Bureau of Information and Analysis Services 2019-2020 it is estimated that Buena Vista County school's enrollment was 43% white, with the Storm Lake School District reporting 16% white. Buena Vista County Schools include Albert City-Truesdale, Alta-Aurelia, Newell-Fonda, Sioux Central, and Storm Lake. Crawford County was 52% white, with the Denison School District reporting 31% white. Crawford County Schools include Ar-We-Va, Charter Oak-Ute, IKM-Manning, Denison, and Schleswig. Sac County was 92% white, with the Schaller-Crestland Community School District reporting 86% white. Sac County Schools include Odebolt Arthur Battle Creek Ida Grove, Schaller-Crestland, and East Sac County. 
While this has been a learning experience in many day-to-day living situations, many have reported that diversity is also beneficial. Children learn to accept others for differences and learn from various cultures.

Economic deprivation in our area is evidenced by the fact that the counties *Estimates for Median Household Income and Per Capita Income, U.S. Census Bureau; American Community Survey 2014-2018*, U.S. Census Bureau QuickFacts: United States Data for Decision Makers Data for Decision Makers (iastate.edu), County Profile reports published by Iowa State University Extension and Outreach 11/25/2010. The Counties of Buena Vista, Crawford and Sac are less than the median household income in the State of Iowa and United States of America. Buena Vista County \$54,556. or 35.7%, Crawford County \$53,609. or 34.5%, Sac County \$54,958. or 35.9%, State of Iowa \$58,580. Or 33.5%, United States \$60,293. Socioeconomic Profile data also shows Persons in poverty, percent Buena Vista County 10%, Crawford County 12%, Sac County 11%, State of Iowa 11%, United States 11%.

Economic deprivation is also demonstrated by *Iowa Public School K-12 Student Eligible for Free and Reduced-Price Lunch 2014-18* **percentages**: 2018: Buena Vista County 60.5%, Crawford 65.4%, Sac 42.7%, versus the State 40.5%. Free or reduced-price lunch eligibility [KIDS COUNT Data Center] Why this indicator matters? Eligibility for free or reduced-price lunches has increased 53 percent since 2000. Increases have been noted in every Iowa County with some more than doubling their rate during this time. In 2018 Buena Vista County was at 61%, Crawford County 65% and Sac County 43% all above the state percentage of 41%. 


Individual birth risks that relate to school readiness. Statewide Needs Assessment findings using the Integrated Data System (IDS) 2017 kindergarten cohort (n=27,321) identified significant birth risks with known associations to early health and school readiness outcomes. Compared to national estimates, Iowa evidence higher percentages of children born to a teen mother (4% vs. 2%, nationally) and to a mother who smoked during pregnancy (23% to 7%, nationally; note that the national definition did not include the 3 months prior to pregnancy, which Iowa's definition did include). Findings also showed that children born to teen mothers, mothers without a high school education, families in poverty, or were exposed to prenatal smoking are more likely born in rural counties compare to urban counties.

The chart indicates the percentage of children in the IDS 2017 kindergarten cohort (n-27,321) with identified birth risks statewide relative to children born and attending kindergarten in Buean Vista, Crawford, and Sac Counties. All variables were derived from the Vital Statistics birth records. Poverty was defined if the mother was receiving WIC or Medicaid at the time of the child's birth. Pre-tern birth (before 36

weeks gestation), low birth weight (weighting less than 2,500 grams), and inadequate prenatal (no medical visits within the first trimester or fewer than 4 visits throughout the pregnancy) were defined using the Centers for Disease Control national definitions. Prenatal smoking included children whose mothers smoked three months prior to or anytime during pregnancy. Cumulative birth risks. As children often face multiple risks that are highly correlated and accumulate over time, a cumulative risk approach was utilized to understand the multiple risk context and provide deeper insights into how agencies might address the needs of vulnerable




children. A cumulative risk measure was constructed as a sum of the seven (7) individual birth risks identified as poverty, unmarried motherhood, low maternal education, teen motherhood, preterm/low birth weight, inadequate prenatal care, and prenatal smoking.


capacity does not meet the number of children under nine years of age.

Children under six years of age are more likely to require child care. Considering the data of the number of child care slots identified with Child Care Resource and Referral in 2020 (1557) and the population of children age 0- 5 Buena Vista County 1, 739 Crawford 1,422 and Sac 705 for a three County total of 3,866 (Population Data Source: Woods & Poole Population Estimates as of Dec 31, 2019). The three counties may need 2,329 additional child care slots to just meet the needs of children under age six. The chart below shows the decline of child care slots in Buena Vista, Crawford, and Sac Counties. Unduplicated percentage of children with preschool experiences (2017


Iowa's Integrated Data System (IDS) documented counts of children from across different types of preschool programs for the first time.



Findings using the IDS data for the 2017 kindergarten cohort (n=27,321) indicated that 73% of Iowa children experienced at least one center-based experiences was defined by participation in a Department of Education funded preschool program (e.g., Statewide Voluntary Preschool, Shared Visions, or IDEA), receiving child care assistance from DHS, and /or who completed a Teaching Strategies GOLD (TS GOLD) assessment (which indicated that the child attended a center that participated in TS GOLD assessments through the State of Iowa license and included Head Start programs and many other privately funded preschool centers). 

Section II: Community Needs Assessment

Development of the Community Needs Assessment

The collaboration team of BVCS Early Childhood Iowa, Decat/CPPC Areas of Crawford - Sac, and Buena Vista and Child Abuse Prevention Councils have utilized a combination of methods to determine and prioritize the needs for the children age 0-5 and youth 6-18. We have researched the data and statistics from sources on the internet and compiled internet data from various sites identified in Section 1 of this Community Plan.

Community Coalition Members (local services providers) participated in a strategic planning session during scheduled bi-monthly meetings. They provided input on the strengths, resources, gaps, weaknesses, family stress, resources, and better ways to serve the community.

Locally we surveyed parents using an electronic survey and paper copies. Parent Surveys consisted of open-ended questions, and check boxes for utilized community services. The surveys were distributed to schools, preschools, family support programs, and mentoring programs in Buean Vista, Crawford and Sac Counties. 110 responses were received from the parent surveys.

Reviewed other community assessments including public health/hospitals, community action agencies and Prevent Child Abuse Iowa. We continually gather information about local needs at local Community Coalition meetings, which have representation from various community partners.

Analysis of Data

Data points identified as areas of concern:

- Poverty as displayed in the high percentage of Free or Reduced School Lunch
- Teen Age Pregnancies
- Cumulative birth risk (prenatal smoking, low education, marital status, poverty)

- High percentage of all parents in the workforce
- Reduction of child care spaces
- Juvenile arrests
- Possible suicide in teens

Local Service Providers:

Primary strengths identified by the service providers during the local community coalition meetings included:

- Diversity and participation in communities
- Wide variety of resources
- Teamwork and collaborative planning
- Dual Language Learner programs at Storm Lake and Denison Community School Districts
- Family Treatment Court Programs
- Family Support programs

Gaps, Weakness, and Stress for families:

- Mental Health knowledge of mental health youth and adult, mental health factors and substance abuse, services for children, help in school or community.
- Child Care affordability, quality, child care assistance providers, Foster Care options, spaces for child care, respite care.
- Employment/Work unemployment, financial stress from losing job, long hours at work, Refugee unaware of manual labor required at packing plant jobs, ability to take off work to attend services related to substance abuse.
- Housing rental property, homeless (no shelter) want to stay in school district, finances to help secure housing, bed bugs in rental property, home furnishings.
- Financial food insecurities, lack of Medicaid dental care providers, cost for health care deductible and co-pay, COVID-19 stress of family income, help for family when an item is not considered a necessity.
- Literacy adult literacy (reading and importance of mail), multiple languages, cost of language line, interpreters for various languages.
- Transportation cost of taxi, lack of car, affordable transportation (groceries, school etc.),
- Other: connection to social supports, know resources, more services for substance abuse, activities during cold weather months.



Parents reported using a variety of services provided throughout the counties. According to the parents surveyed Public Libraries are widely utilized by children and families. The survey shows parents are connecting to services in addition to the continued necessity to provide awareness of community supports. One comment suggested the need to connect to parents beyond the use of brochures or flyers. The chart identifies programs that rated above 15% responding they had used the service.

Community Assessments:

Prevent Child Abuse Iowa assessment shows percentages of abuse, neglect, and all risk factors. The data's standard deviations for all risk indicators correlated with maltreatment were summed and then the counties were ranked by the sum. The factors included are child abuse and neglect, child poverty, teen births, low-birthweight births, children living with parents with 4+ ACEs, children living with domestic violence, children living in households where rent is more than 35 percent of income, child population between the ages of zero and five, and children living with mental illness in the family. Buena Vista County **75**, Crawford County **55**, and Sac County **19** respectively of the 99 counties in Iowa. (Iowa Child Maltreatment Prevention Data Update 2019). The higher the number the higher the percentages of abuse, neglect, and all risk factors. pcaiowa.org



Community Action Agencies (Head Start/Early Head Start) three Community Action Agencies provide services Upper Des Moines Opportunity, Inc (Buena Vista County) West Central Community Action (Crawford County) and New Opportunities, Inc. (Sac County). Assessment and Annual Report reflect working toward a variety of items and services for children and families. Healing Iowa ACEs 360 – Adverse Childhood Experiences (ACEs) The 2018 Iowa Youth Survey (IYS), which captures the perceptions, attitudes, and behaviors of 6^{th} , 8^{th} , and 11^{th} graders, shows the challenges noted: 21% have had thoughts of suicide – 15.7% do not feel safe at school – 15.4% live in a home where people have a serious alcohol or drug problem – 10% disagree with the statement "I have a happy home."



Section III: Community Collaborations

Collaborative and Networking Opportunities

Collaboration is obtained by partners engaging in a process through which they constructively build an interdependent system which includes a common mission, comprehensive communication and planning, pooled resources and shared risk and products.

Community Coalitions are organized/facilitated by the BVCS Early Childhood Iowa, Program Director and Decat/CPPC Program Coordinators. Community Coalitions also serves Pregnancy Prevention and Tobacco Prevention Councils.

The Community Coalitions are comprised of a wide variety of service providers/citizens,

Agencies that serve the counties and community members of Buena Vista, Crawford and Sac Counties are invited to attend local Community Coalitions. The councils meet on a bi-monthly basis on regularly scheduled days. Buena Vista County is scheduled to meet on the second Thursday at 10:00 with the main location at Our Place in Storm Lake. Crawford County is scheduled to meet on the third Tuesday at 1:00 pm with the main location ISU Extension in Denison. Sac County is scheduled to meet on the second Monday at 9:00 am with the main location at Sac County Law Enforcement Center. Starting in March of 2019 the Community Coalition started to meet virtually due to the COVID-19 pandemic. The members have found virtual participation to meet the needs of the Coalition and will review if a possible hybrid model would work in the future.

The Community Coalitions meetings are to promote communication between agencies with similar goals. Meetings can consist of a speaker that gives information about services or events happening in their County. Following the speaker, a planned meeting is held. The meetings consist of review of previous minutes, Council decisions, community sharing, and may include assistance with community assessments/surveys, recommendations for programming, problem identified in the community, brainstorming of resources available in the community.

Section IV: Fiscal Assessment - Early Childhood

Buena Vista, Crawford, and Sac Counties are fortunate to have a solid base of early childhood services funded from federal and state entities. Following is a breakdown according to types of early childhood services. Information was collected from agencies and schools in March of 2021. Section V: Summary

Buena Vista, Crawford, Sac Early Childhood Iowa and Decat/Community Partnerships for Protecting Children and the Child Abuse Prevention Councils would like to extend a note of appreciation for all who participated in the development of this Community Plan. Based on the data reviewed and feedback gathered at various stages during the assessment process, it was apparent that many organizations and parents identify similar needs and strengths.

BVCS Early Childhood Iowa, Decat /CCPC and Prevent Child Abuse Councils are not able to provide funds to meet all the needs that affect the families in the area, but the programs we fund are able to make small changes that can have big impacts. Working together allows communities to connect and be able to identify resources that are beneficial in working toward our visions.

The Community Plan 2022 – 2024 was used to develop the priorities identified in the BVCS Early Childhood Iowa Boards Strategic Plan. The BVCS Early Childhood Iowa Board Strategic Plan expands on the desired results identified on page 24 of this document. Alliance of the local area (BVCS Early Childhood Iowa) to the State Early Childhood Iowa Result Areas, types of programs the local area plans to fund, program trend data for funded programs, Community Wide Indicators adopted by the BVCS Early Childhood Iowa Boards Strategic Plan.

In evaluation of the plan there is a continued need to focus on each county's demographic makeup to ensure that programs and services are meeting the needs of the children and families living in the geographical area. Many families qualify financially for free and/or reduced meals and many were identified having individual birth risks. The need to keep residents informed of resources and programs that can assist and relieve stress. There is a need to increase the availability, affordability and quality of early care and learning environments (child care). Risk factors related to Adverse Childhood Experiences can be found in each county, Buena Vista County has the highest indicators according to Prevent Child Abuse Iowa (page 20). Commonalities were identified by parents, providers, and other assessments. The importance for programs and/or service providers to continue collaboration efforts to serve the children and families in the communities of Buena Vista, Crawford, and Sac Counites is important to make changes and improve the outcomes for the future of our children.

Hopefully, you find the Community Plan to useful tool develop and expand upon services for children and youth.
