| Maternal Child Health Grant Awards | Annette K shared the Maternal Child Health (MCH) grant was granted to Webster County serving Buena Vista and Sac Counties. Budget meeting approved to enter into contract based of the Request for Renewals from New Opportunities, Inc and MATURA to provide oral health services to Buena Vista and Sac Counties. Oral Health services are provided by <i>i-smile</i> coordinators housed in the MCH agencies. Annette K Talked with MATURA and New Opportunities. New Opportunities is appealing the Iowa Department of Public Health decision. Annette K asked Shanell Wagler for input on moving forward. Annette K read her reply, <i>Since one of the requirements is for the organization to hold an MCH contract or an agreement with an MCH agency, this is almost a “sole source” situation or “emergency procurement” to get through FY 17. Suggest doing a Request for Proposal in FY 18 to allow other MCH organizations to bid, if they can serve all or part of the area.</i> Annette K contacted Webster County, she shared a copy of the current RFP’s, and draft contract, and they are willing to provide the services. Discussion by the Board was held about the oral health contract for FY 17, New Opportunities appeal, timeline for contract, waiting until August appeal may be done, being able to provide services if contract starts in October. October is the Federal Fiscal Year used for the MCH grant. Motion by Mike B to contract for services to providers holding the Maternal Child Health grant in Sac and Buena Vista County starting October 1 st , 2016 for the oral health services with the same budget amount previously approved. Seconded by Jane L, a voice vote was held, all in favor. | Motion Carries |
