Plains Area Mental Health Center, Alecia Dougherty Turning Point Crisi Home open in Sac City has 8 beds with a 9th possible. Turning Point is not for people who need hospitalization or waiting for placement. It is a prevention mode, criteria's are in place. Intent is stay for 4 to 5 days with daily therapy, medication management, and open 7 days a week 24 hours a day. Turning Point is only for the Rolling Hills Mental Health Region, paid for by counties.
