# **Early Childhood Iowa (ECI)**

Early Childhood Iowa has a long and rich history of investing in young children, birth through age five, and their families. Early childhood experiences have an impact on the health, success in school, success in work, and in life overall.

Paired with research on the importance of the first three years of life, in 1998, the Iowa Legislature created the Iowa Community Empowerment. This provided funding for early childhood services with the establishment of state and local partnerships. In 2010, the Iowa Legislature passed additional legislation transitioning Community Empowerment to Early Childhood Iowa and designating ECI as an umbrella for the local area boards and partnership of ECI Stakeholders Alliance. (Iowa Code 2561). The Stakeholders Alliance coordinates with the State Board and also serves as the State Advisory Council.

OUR VISION FOR IOWA'S CHILDREN:



Local Early Childhood Iowa Areas are provided throughout the State of Iowa and are partners in the Early Childhood Iowa Initiative. Local ECI Areas are geopolitically self-defined within state-legislated parameters. Use community planning to drive local decision making. This Community Plan is a guide for the process to coordinate local planning and purchasing/contracting for services. Each local area is overseen by a board and Early Childhood Iowa Team who reports to the State Board. Oversite includes approved budgets, technical assistance, monthly meetings, mid-year reports, annual reports for statewide performance measures and funding, along with a designation process to determine the areas are meeting the requirements.

The ECI Stakeholders Alliance is a public-private group focused on early childhood system development with a steering committee and six component groups to guide the system. Most recently Implementation Teams were established. They will guide the work taking a focus on identified strategies in the We Are ECI Strategic Plan. Anyone with an interest in early childhood can participate.



#### Community for Partnerships for Protecting Children (CPPC)

Works with communities to prevent child abuse, neglect, re-abuse, safely decrease the number of out-of-home placements, and promote timely reunification when children are placed in foster care. Communities develop partnerships across collaborative networks to implement prevention strategies, provide early interventions, and share responsibility for the well-being and success of all children and families. The Community Partnership approach involves four key strategies which are implemented together to achieve desired results.

#### **Use of the Community Plan**

We recognize that many agencies serve families and in society today can be complex. The BVCS Early Childhood Iowa (BVCS ECI) 3-County Board serving Buena Vista, Crawford and Sac Counties has assembled a Community Plan centered on families and young children. Research from various websites and surveys assisted in the compilation of the materials. The Community Plan is organized in five sections designed to provide a quick guide for your use.

**Section 1** emphasis is on identifying the area served, community partners, purpose and geographical/demographics for the three-county area centered around the zero to eighteen population in Buena Vista, Crawford, and Sac Counties.

The profile assists the BVCS Early Childhood Iowa Area and/or readers to understand and make decisions in relationship to the three counties. Utilize the geographical/demographics data to study, capture, and analyze subsets within a given population.

**Section 2** examines the community needs assessment completed for the three counties, development of our strategic plan, priorities and community wide indicators used to track programs. Use this information when you are developing or making the case for expanding a current program and/or partnering with BVCS ECI.

**Section 3** focus is on collaboration, defined as: partners engaging in a process through which they constructively build an interdependent system which includes a common mission, comprehensive communication and planning, pooled resources, and shared risks and products. Look at how we can build a sturdy foundation for the children and their families in our communities. This section can be used as a springboard to goal setting and planning for community partners.

Section 5 information for BVCS Early Childhood Iowa Community-wide indicators and trend line data for funded programs.




## **Geographical / Demographic Profile Composition**

Located in West-North-Central Iowa, the BVCS Early Childhood Iowa encompasses the counties of Buena Vista, Sac and Crawford.

Buena Vista and Crawford Counties have a high diversity in race.

Percentage of Population in Buena Vista, Crawford, & Sac Counites by Race/Hispanic Origin






In reviewing data from the Iowa Department of Education, Education Statistics – PK-12, 2022-2023 it is estimated that Buena Vista County school's enrollment was 41% white, with the Storm Lake School District reporting 14% white. Buena Vista County Schools include Albert City-Truesdale, Alta-Aurelia, Newell-Fonda, Sioux Central, and Storm Lake. Crawford County was 40% white, with the Denison School District reporting 29% white. Crawford County Schools include Ar-We-Va, Charter Oak-Ute, IKM-Manning, Denison, and Schleswig. Sac County reporting 90% white, with the Schaller-Crestland Community School District reporting 74% white. Sac County Schools include East Sac County, Odebolt Arthur Battle Creek Ida Grove, and Schaller-Crestland. https://educateiowa.gov/

Economic deprivation in our area is evidenced by the fact that the counties Estimates for Median Household Income (in 2021 dollars), U.S. Census Bureau, Quick Facts, 2017-2021, U.S. Census Bureau QuickFacts: United States The Counties of Buena Vista, Crawford and Sac are less than the median household income in the State of Iowa and United States of America.

Buena Vista County \$53,645 (10.8% in poverty). Crawford County \$55,552. (11.4% in poverty). Sac County \$61,040. (10.0% in poverty). State of Iowa \$65,429. (11.0% in poverty. United States \$69,021 (11.5% in poverty).

Increases have been noted in every Iowa County with some more than doubling their rate during this time. 

## **Iowa's Integrated Data System for Decision-Making (i2d2)**

During Early Childhood Iowa's (ECI) <u>Statewide Needs Assessment</u> and <u>Strategic Planning</u> process of 2019, stakeholders from across the system continually expressed a need for more local data. While Early Childhood Iowa has historically relied on a set of State Board-approved indicators to inform state-level work, access to these was challenging for Local Area Boards as data were drawn from multiple sources.

IA Data Drive was designed to bring all these sources into one location to focus attention on the sets of indicators that are most relevant for early childhood strategic planning.

After meeting with a variety of stakeholder groups throughout 2020 using static reports of local indicators the I2D2 team compiled lists of the most commonly used indicators and prioritized their inclusion in IA Data Drive. Starting with the ECI State Board-approved indicators, we anticipate the addition of future data elements to continue to meet the needs of more diverse community and statewide planning efforts. I2D2's interactive "IA Data Drive" dashboard is here to empower decision-makers with accessible data in an easy-to-use format. What in the past may have been visits to 15 different websites is now just a click away – early childhood trends, local vs. state data comparisons, and more. IA Data Drive provides an assortment of indicators aligned with the most recent statewide annual report from ECI. Access the data drive at the IA Data Drive Login link below.



# Asset Limited, Income Constrained, Employed (ALICE)

ALICE places a spotlight on a large population of hardworking residents who work at low-paying jobs, have little or no savings, and are one emergency away from falling into poverty.

The United Way ALICE Report is the most comprehensive depiction of financial needs in the state to date, using data from a variety of sources, including the US Census. Data is available on the state, county, and municipal level. The report unveils new measures, based on present-day income levels and expenses that show how many Iowa workers are struggling financially, and why.

ALICE represents a growing number of individuals and families who are working but are unable to afford the basic necessities of housing, food, childcare, health care and transportation. Although ALICE is earning income, pays taxes and contributes to Iowa's economy, the household income is not enough to meet a basic survival budget in these categories. 





Reviewed other community assessments including hospitals, community action agencies and the United Way ALICE report. We continually gather information about local needs at local Community Coalition meetings, which have representation from various community partners.

Community Coalition Members (local services providers) provided the top needs they observe during their work with children and families.

Early childhood agencies participated in a strategic planning session during a scheduled meeting. The meeting consisted of reviewing data and gaining input from the workers in the field.

Locally we surveyed parents using an electronic survey and paper copies. Parent Surveys consisted of open-ended questions, and check boxes for utilized community services. The surveys were distributed to preschool parents and the family support programs in Buean Vista, Crawford and Sac Counties. 19 responses were received from the parent surveys.

Crawford County is scheduled to meet on the third Tuesday at 1:00 pm with the main location ISU Extension in Denison. Sac County is scheduled to meet on the second Monday at 9:00 am with the main location at Sac County Law Enforcement Center. The members have found in-person in conjunction with virtual participation meet the needs of the Coalition.

The Community Coalitions meetings are to promote communication between agencies with similar goals. Meetings can consist of a speaker that gives information about services or events happening in their County. Following the speaker, a planned meeting is held. The meetings consist of review of previous minutes, Council decisions, community sharing, and may include assistance with community assessments/surveys, recommendations for programming, problems identified in the community, brainstorming of resources available in the community.

- participation in initiatives that support quality environment, education opportunities,
- oral health prevention (children/parent of children 0-5 years of age),
- early childhood training opportunities or initiatives,
- preschool tuition supports to quality preschool programs,
- consultation; health and safety, business practices, behavioral coach etc.
