Following Tool O unable to allocate to families between 201%-300%. 11 families fell into this FPL. Total amount if would have been able to fund \$10,537.50 based on a sliding fee, at 75% of tuition/maximum set by board.

Funding six entities/programs (preschools). This includes 9 separate classrooms, 2 preschool have 2 sections, 11 different teachers. Scholarships were released late this FY due to the change in Tool O, applying the CCA requirement was a learning curve for parents, preschools, coordinator, delayed the process.

Q 1: Our focus during the summer months is to go to the WIC clinics since the schools aren't in session during those months. We are doing care coordination for children from previous months as well as the current months depending on which clients we were able to connect with in the previous months. The next quarter we will be going into school and daycare settings with school being back in session and will continue to focus on all of our required care coordination for high-risk, no dental home, and no dental visit within the past 12 months.

Q2: We were able to go into multiple settings this quarter to provide dental education, screenings, and fluoride. We have been able to do care coordination in a timely manner and per our protocol we will continue to reach out to the families that we have not been able to get ahold of yet. Out of the total # of children screened, there were 147 of them that have no dental home or haven't been to the dentist in 12+ months and we are doing care coordination for these clients as well to help get them an established dental home.

Striving to serve 950 children. Striving to screen 665 children. Half way through the year serving over half of the children striving to provide services too.

FSS completed a 24-month developmental screening with one of the kiddos at a home visit and there was some concerns with his fine motor development. FSS discussed this with Mom and talked to her about sending a referral to AEA for further evaluation as he was boarder line scoring in the "black zone". Mom had some hesitentencies and confessed she may not have been giving her son enough opportunities based on the questions from the ASQ and asked for a few weeks to work with him on fine motor activities before she makes a decision. When FSS came back for the next visit Mom had shared four fine motor activities the family bought and put together and have been working on every day with their son along with what they just have been incorporating in his day to day life by encouraging him to use silverware to feed himself and helping brush his teeth twice a day and dressing himself. Now just 4 weeks later FSS can see the improvement and increased strength in his fingers as he completes the same fine motor activities from the ASQ screening.

As of December 2025 FSS in Buena Vista County ended employment. Crawford County Community Health has been advertising for this position and currently have two applicants. Interviews are currently scheduled for both applicants. The Program Director will be provided updates as we transition through the hiring process. The Sac County Family Support Specialist, is contracting the families that remained on the program after the workers departure. New referrals are being filtered through the Program Supervisor, and assigned or referred onto other programs for services.

Provider Development Mini-Grants

The intent of this min-grant is to extend professional development that is beyond a programs reach/budget. The funds are designed to supplement, enhance programs, and allow staff to attend training in which funding is not available by any other source.
